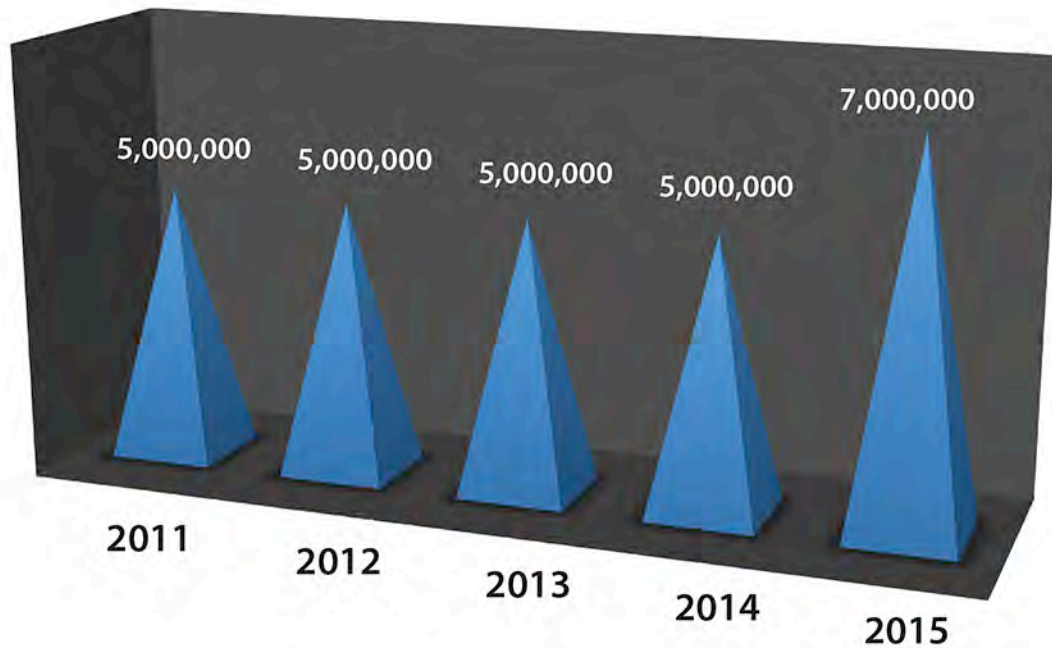

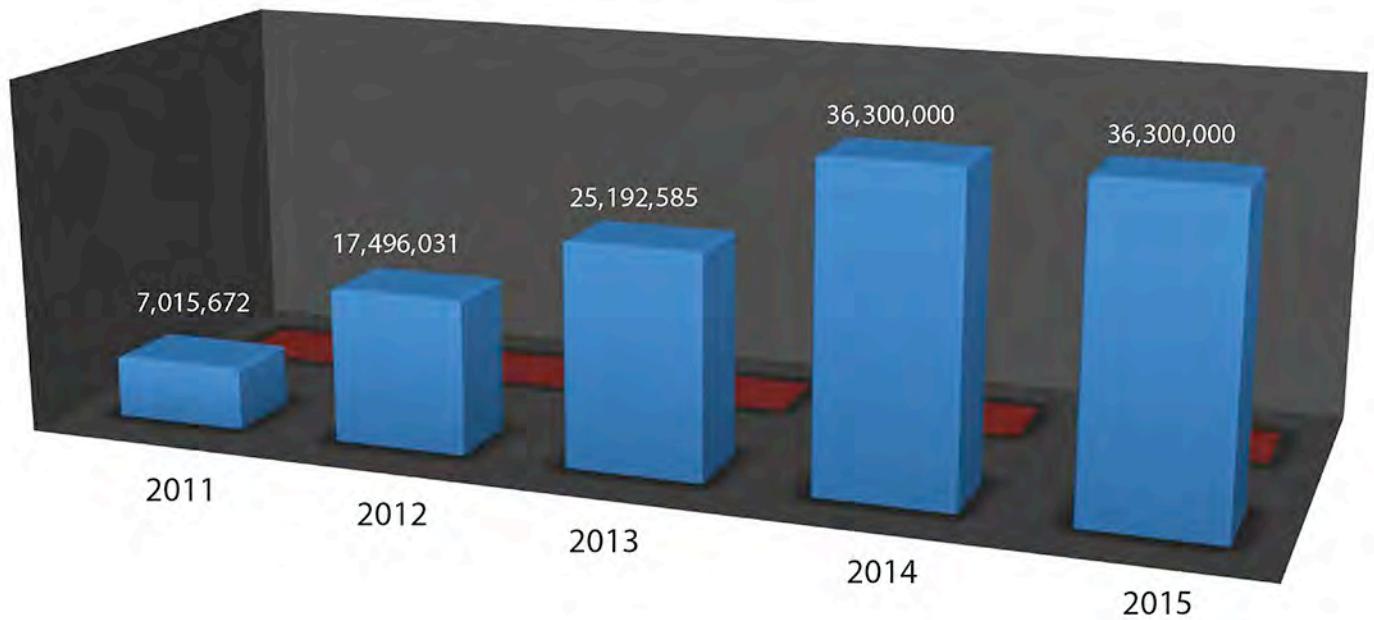

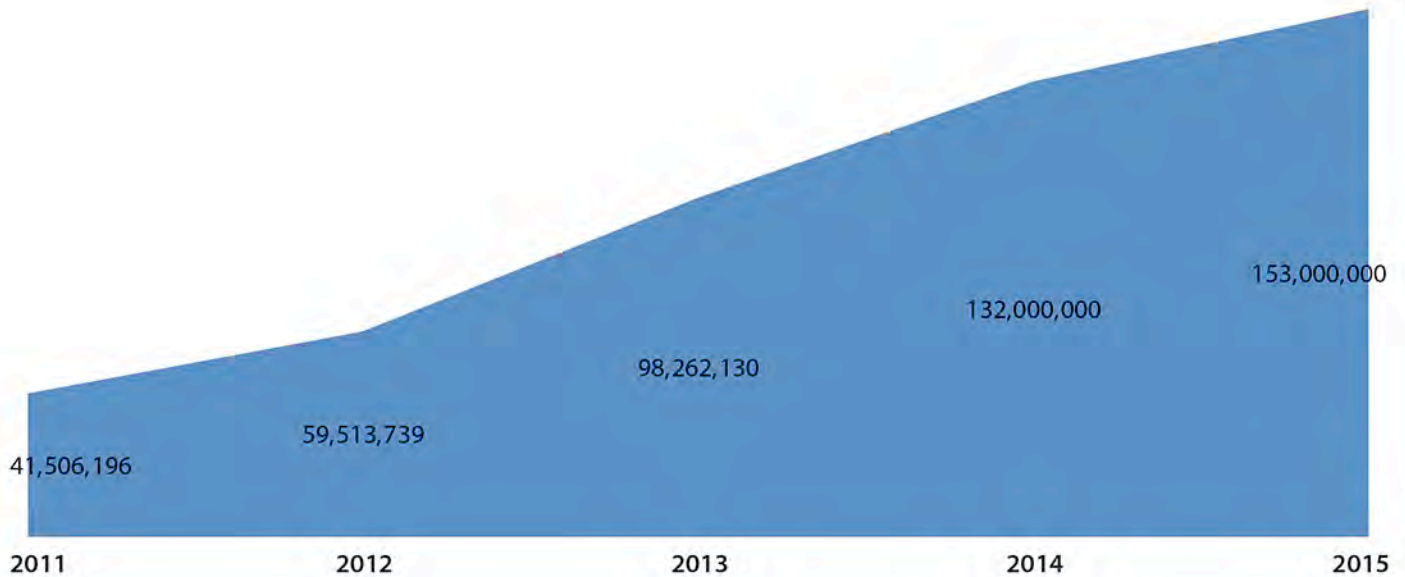

Performance progress 2011 - 2015

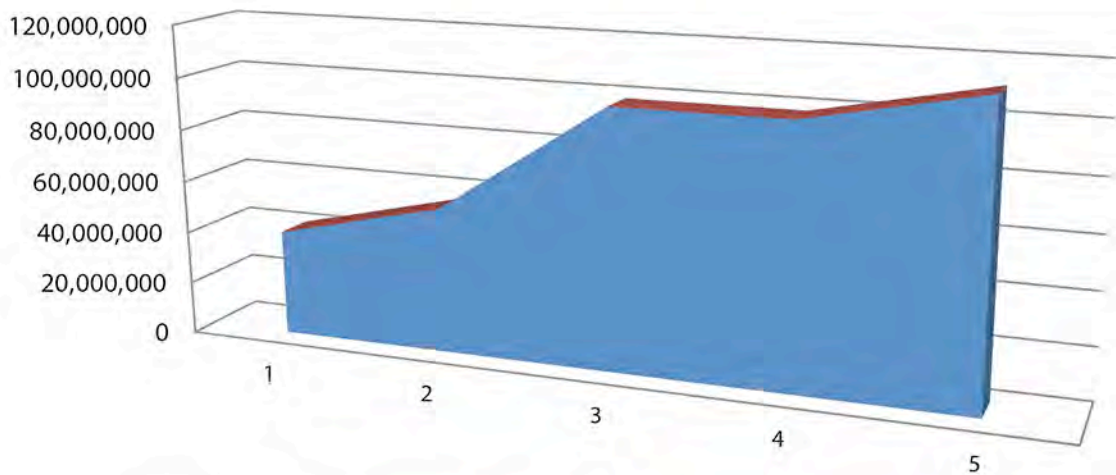
Total Assets
